Mandi (H.P.) have successfully qualified in recent recruitment test of Constable held in District Mandi in the year 2022 and have also been declared medically fit by the CMO Regional Hospital Mandi and your Character and Antecedents have been found satisfactory on verification on per attestation form filled up by you. You are hereby offered the post of Constable on provisional basis against the resultant vacancy of 3rd India Reserve Battalion, Pandolh, District Mandi (H.P.) in the initial pay of Rs. 20,200/- of the minimum of first cell of level 3 of pay matrix under Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 per month plus other allowances as admissible under the rules or as may be sanctioned by the Govt. of Himachal Pradesh from time to time.

3. That your services can be utilized anywhere in Himachal Pradesh as well as in other Union of India or abroad on requisition of Central Government.
4. That your services will be governed under H.P. Police Act 2007, and Punjab Police Rules as applicable to the Civil Armed Police Battalions including India Reserve Battalion.
5. That you shall produce educational qualification certificate of 10+2 or equivalent in original along with written acceptance of this offer of appointment.
6. That you shall produce proof of date of birth i.e. Matriculation certificate etc.
7. That you shall produce a certificate of having only one living spouse or being unmarried.
8. That you shall produce original certificate of SC/ST/OBC/Wards of P/Wards of Ex-servicemen/IRDP/HHG/EWS etc. category duly issued by the competent authority in case of belonging to the particular reserved category against which selection has been made.

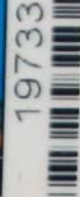

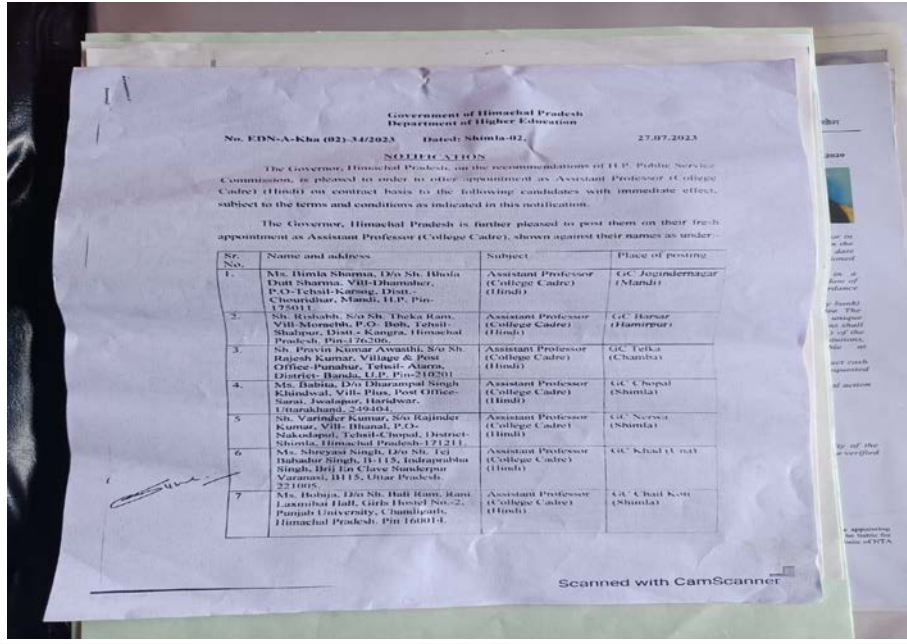
