1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Established in 1994, Government College, Karsog, a premier educational institution caters to the needs of the students of rural area. Affiliated to Himachal Pradesh University, Shimla and Sardar Patel University (SPU), Mandi (HP), it offers graduate courses in Humanities, Sciences, Commerce, and post-graduate courses in English, Hindi and Political Science. The motto of the college is "???????????????????", which means "Knowledge is the Elixir of Life". The primary objective of the institution is to equip and enable students with the knowledge and skills that become instrumental in making them productive to the society. The institution primarily focuses on academic excellence through the use of the state-of-the art facilities, personality development and social orientation of the students. Thus, the college aims at providing quality education to the students by grooming them into wholesome personality. Sincere efforts are made to bridge the gap between words and deeds, promises and performance.

The mutual bond that the staff and students share is the testimony to the fact that the institution is able to build an amiable community interface. Developing the sense of selfless service among the students through co-curricular pursuits, they are motivated to contribute towards their immediate surroundings. The institution engages the students in activities combined with education to promote sustainable and eco-friendly practices.

The forte of the institution lies in maintaining a congenial learning environment in terms of the state-of-the-art infrastructural facilities that provide them a platform to grow. Well-equipped labs, ICT lab, Language-cum-Career Lab, Computer Lab, Tally ERP 9.0 software, Library with 14,475 books on different subjects, newspapers, magazines, journals, etc., INFLIBNET and an e-corner in the library, Smart Class Room, Conference Hall, Music Instruments, etc. are also available to enhance the personal abilities and competence of the students.

Facilitating the basic amenities in the campus, LED lighted, Solar Water Heating System enabled Girls' Hostel, Common Room, Sports Facilities, Eureka Forbes Industrial Water Purifier facility have been provided to the students.

Internal Quality Assurance Cell (IQAC) with the patronage of the Government of Himachal Pradesh and concerted efforts of enthusiastic team of staff members is working assiduously in inching towards the excellence.

Vision

The vision of the institution is to achieve excellence and noble character through Knowledge. The vision of college has been derived from the Sanskrit language, "?????????????" which means "Knowledge is the Elixir of Life". The endeavour of the institution is to instill the core values of character and commitment that paves the way for attaining knowledge.

Mission

Keeping in view the vision of the institution, the main thrust areas are highlighted in the mission statements:

The emphasis is laid upon grooming the wholesome personality by imbibing core values— discipline, character-building, humility and commitment. The work-culture of college instills its students to be an asset to their immediate society and be productive in translating their role as good citizens.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- 1. Government College Karsog, District Mandi (HP) primarily caters to the needs of the students of the rural area and economically weaker sections of the society and strives to transform their lives through value based education.
- 2. The strength of the institution is its well-qualified, experienced and committed faculty members, industrious administrative staff, state-of-the-art infrastructure having well-equipped college library, an access to e-books and e-journals through INFLIBNET, e-corner and NDLI facility, interactive Smart Classrooms, Conference Hall, Girls' Hostel, sports facilities including a gymnasium and high speed Broadband/Wi-Fi internet access and other requisite facilities.
- 3. The faculty appointed by Himachal Pradesh State Public Service Commission, Shimla has a rich academic and research base and they have attended orientation and refresher courses, seminars, workshops and conferences to get updated on the changing trends in the field of education and related areas.
- 4. Add-on courses on 'Accounts Executive', 'Social Media Managers' and 'English, Employability and Entrepreneurship' were introduced and skill-oriented education is the primary aim of the degree programmes.
- 5. Feedback from students, faculty, parents and alumni is given due consideration for quality improvement. Alumni Association plays active participation in the development of the institution.
- 6. Remedial measures and tutorial hours for slow and advanced learners are arranged as per demand.

- 7. NSS Camps, NCC Camps, Blood Donation Camps, Social Awareness Drives (AIDS awareness, social and gender equity, public health, National Integration, etc.) and other outreach activities are conducted to integrate the academic programmes with social and community objectives building community interface.
- 8. Involvement of students in organising various functions by different clubs, societies and departments throughout the year complements class-room interaction.
- 9. Financial support is ensured to students through various scholarships.
- 10. A committed IQAC is bound to quality enhancement and sustenance initiatives through interwoven curricular, co-curricular and extra-curricular activities.
- 11. Pollution-free and eco-friendly green and clean campus.
- 12. Healthy teacher-student relationship. The availability of teachers outside the class room and after working hours to guide and to counsel is a hallmark in this regard.
- 13. To instill an attitude of respect towards the environment and encourage students not to involve themselves in ragging and any other violent activity in college campus.

Institutional Weakness

- 1. Being an affiliate institute to Himachal Pradesh University, Shimla (HP) and Sardar Patel University, Mandi (HP), and managed by the Department of Higher Education, Government of Himachal Pradesh, the institution is dependent upon government funding for its growth and developmental activities.
- 2. The transfer of faculty in the middle of an academic session hampers the teaching-learning process.
- 3. Lack of an interactive mechanism and formal linkages with centres, industries as there are no major industries operating in the region due to the geographical isolation of the college.
- 4. No autonomy in academic and financial matters.
- 5. Unavailability of Boys' hostel and staff quarters. The development of these facilities is hampered by lack of adequate land with the institution.

Institutional Opportunity

- 1. Scope for better research culture and need to explore the avenues for taking up major and minor projects from different funding agencies.
- 2. Introduction of more add-on programmes and self-financed courses like BBA, BCA, B. Voc., Biotechnology, PGDCA, skill enhancement courses, e-commerce, communication skills, etc. for acquisition of potential /skills for employability.
- 3. Exploring the possibility for the expansion of the college campus.
- 4. Need to harness organic farming and to set up Vermi-compost facility.
- 5. Introducing new area specific courses on agriculture, horticulture, and sericulture.

Institutional Challenge

- 1. The lack of exposure of students hailing from rural areas prove to be a major hurdle in realising the real potential of the students in academic and related activities.
- 2. Students are mostly first generation learners getting little motivation from the parents or the society.

3. Poor ICT knowledge of the students who come from different school background.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The curriculum for all courses followed by the college is designed by Himachal Pradesh University and Sardar Patel University, Mandi (HP). However, some faculty members contribute in designing the curriculum as members of the board of studies/committee. The prospectus contains the structure of courses available for the students to pursue and the academic calendar. The Induction Programme for new entrants is conducted to familiarise the students with the curriculum and the facilities available in the campus. The faculty ensures well-planned curriculum delivery as per the guidelines laid out in the academic calendar.

The college offers UG programmes in 18 subjects in Humanities, Science and Commerce under the Choice Based and Credit System (CBCS) along with post-graduate courses in English, Hindi and Political Science. The college provides diverse and flexible programmes of study as envisaged in CBCS guidelines. Students are allowed to select courses according to their choice thereby promoting interdisciplinarity. However, the choice and allotment of courses to the students is subject to merit.

The goals and objectives of the curriculum are transmitted to the students by the faculty through interactive teaching. The learning course outcomes of different subjects are delineated by the faculty with the students in the classroom and are also flashed on the college website. Emphasizing on the cross-cutting issues as described in the curriculum, the integrated, interactive and engaging curriculum delivery tries to build ethical values, gender equity, human values, environment consciousness, etc. The college maintains a tradition to organise expert lectures on the curriculum to provide a bigger canvas to the learners.

Add-on courses on Accounts Executive, Social Media Manager and English, Employability and Entrepreneurship (EEE) were introduced in the institution under the aegis of Himachal Kaushal Vikas Nigam (HPKVN).

Ensuring the quality education, the college strictly adheres to Comprehensive Continuous Assessment/Evaluation of the students. To make the system transparent, feedback on the part of the faculty, student feedback and feedback from stakeholders? parents, alumni is also taken which helps in identifying the new courses/ programmes that can be introduced in the ensuing academic session and the valuable suggestions for the betterment of the institution.

Teaching-learning and Evaluation

The institution promotes the student-centric environment where the students get an open access to learning resources. Following the transparent online admission process, the students can opt for the course of their own choice. After getting the approval from the admission committee, students get admitted on the basis of meritlist in respective Discipline Specific Course (DSC). Further, in order to ensure equal opportunities to all in the admission process, reservation policy is strictly followed as per the State Government/HPU/SPU norms.

The college follows the teaching, learning and evaluation schedules notified by Universities. The teachers deliver their lectures as per the programme outcomes and course outcomes of different subjects/courses. The

faculty also strengthen their knowledge-base and keep abreast with the latest trends in their particular field to make the teaching-learning process an enriching experience.

To make the teaching-learning process effective, teachers use student-centric methods by incorporating the ICT- enabled tools including online resources. Guest lectures, workshops/ seminars/ presentations are conducted to sharpen the skills of the students. To promote the participative learning, the students are encouraged by debate, discussion, seminars and presentation methods. To inculcate the problem-solving skill among the students, brainstorming sessions are simulated where the students work as a team and come up with their valuable inputs. The college conducted 'Grammar Workshop' (Department of English), project work (Department of Life Sciences), Theatre Workshop and adaptation of stories by Munshi Prem Chand (Dramatic Club) to enhance the experiential learning of students.

Internal assessment for all courses is awarded as per the CBCS guidelines laid down by the universities. Continuous and Comprehensive Assessment (CCA) comprising of attendance (5 Marks), class tests (5 Marks), assignments/seminar/presentations, question- answer sessions/ quizzes (10 Marks), mid-term examinations (10 Marks), term-end examinations (70 Marks) and for subjects having practical? practical (20) and term-end examinations (50 Marks) are strictly adhered. The students' grievances related to internal examination and evaluation are redressed promptly.

The IQAC of the college also plays a pivotal role in ensuring effective and goal-oriented teaching-learning process and quality of education by encouraging the faculty members to attend seminars/conferences/workshops/Faculty Development Programme (FDP) orientation programme, etc.

Research, Innovations and Extension

Being an affiliate college, research activities are carried out by the faculty members at their own level. Twelve faculty members are Ph.D. and five members are pursuing their Ph. D. Only some faculty members are engaged in supervising the research students as co-guide. The faculty has enlisted their research papers in UGC CARE List Journals, other Peer-Reviewed journals of repute, edited the book, chapters in books/ conference proceedings, etc.

To promote the research, the teachers are granted study leave by the Higher Education Department, (HP). The teachers also participate in In-service Training Programmes of varying durations conducted by different government and other bodies. For enhancing the skills of faculty, the institute encourages them to participate in Refresher Courses, online MOOCs, Short-Term Courses, Workshops, national and international conferences and seminars. The faculty members are encouraged to send proposals to UGC/ICSSR/CSIR and other funding research agencies for research and innovation.

As far as outreach programmes and extension activities are concerned, the institute provides ample opportunities for the students for their holistic development. The students are equipped with social and life skills like maintaining personal hygiene and cleanliness in society, engendering environment consciousness, etc. These skills make them active contributors, addressing local challenges and fostering sustainable development. Programmes of social importance are carried out by Triveni?NCC, NSS and Rovers and Rangers units of the college. The extension activities foster the spirit of social and humane consciousness that motivates them to reach out to their fellow beings, particularly the needy and the marginalised. The efforts of the institute have been acknowledged by the local administration and departments. The college also recognise the efforts of the students by awarding prizes to them at the Annual Prize Distribution Function.

Infrastructure and Learning Resources

Spread over an area of about 14,360.28 square meters (with 8045.34 square meters of built up area) of land, the college has become the premier institute of education in this part of the state. The spacious building includes an administrative section, well-lighted and ventilated classrooms and fully-equipped and updated laboratories for Physics, Chemistry, Botany, Zoology, Geography, Computer Lab and a Language-cum-Career Lab. IT labs are equipped with latest computers and broadband connectivity (Bharat Fibre 250 mbps). The college campus has been made Wi-Fi enabled. The college also has a Library, Conference Hall, Seminar Hall, Staff Room, Library and a Common Room for girls. There are separate rooms for House Examination, NSS, NCC, Rover & Ranger, Sports, CSCA Room and separate faculty cabins. The college also has an IQAC Cell/UGC Resource Centre. The Canteen facility is also available to the students adjacent to the college building. The facility of Girls' Hostel has been provided for the girls and it can accommodate 53 girls.

The college library provides services that support the diverse curriculum in Science, Arts, and Commerce as well as on subjects of professional and general interest. The reasonable collection of books, magazines and other library material provides adequate resources to explore all areas of human knowledge within the framework of learning. ICT rich environment has been instituted to encourage students to become more focused in their learning. Access to online educational resources is provided through the INFLIBNET. Infrastructure of the college is also used by several outside agencies for conducting examinations and other government programmes. To keep the environment of the college clean, healthy and eco-friendly, LED lighting has been instituted in the campus along with a Solar Water Heating System for the Girls' Hostel. Use of polythene bags and the burning of dry leaves have been prohibited in the college campus. The rain-harvesting system has been set up to store the water and is utilised in the Botanical Garden and watering the plants in the campus.

Student Support and Progression

The college maintains the tradition of facilitating the student support by providing facilities under different clubs/societies/committees. The progression of students from one level of education to the next higher level is encouraged. Institution has taken initiatives for the capacity development and skill enhancement through various activities that help in improving their soft skills, language and communication skills, life skills, ICT skills, etc. The Career Counselling Cell guides the students for competitive examinations and imparts relevant information and support regarding admission to academic/ professional courses offered by the state and other universities/institutions.

To redress the problems/ complaints of the students, the institution has framed different committees like Grievance Redressal Cell, Anti-Ragging Committee, SPARSH Cell, CSCA Advisory Committee, etc.

The college atmosphere is enriched with a host of curricular and co-curricular activities. Events at the departmental/faculty level are organised to supplement quality teaching and personality development of students with activities like youth festivals, sports activities, programmes by NSS/NCC/Rover & Ranger, functions organised by subject societies, etc. Keeping in mind the vision and mission of the college, such activities are well-synchronised with the annual calendar of the college/university. Students who excel academically or in other fields are duly rewarded and recognised in Annual Prize Distribution Function.

Besides, the meritorious students are awarded scholarships like Kalpana Chawla Chhatrvriti Yojna and the students from SC/ST/OBC categories and economically weaker sections are also provided equal opportunities

by award of scholarships and stipends as per the government norms. The college magazine "Kamaksha" provides a platform to the budding writers of the college to hone their creative urge.

The College Student Central Association (CSCA) provides leadership to students through their involvement in academic and developmental activities of the college. Adequate representation is given to the students in various important committees of the college like the IQAC, anti-ragging committee, discipline committee and the organising committees for different events organised by the college. The college has also adopted a 'Student Charter' clearly defining the duties and responsibilities of the institution towards the students and viceversa.

The institution has Alumni Association that shows active participation in the development of the college.

Governance, Leadership and Management

Fostering leadership qualities among faculty and the students, the college administration executes academic and other programmes in accordance with the vision and mission of the institution. The college has a decentralised, democratic and transformative leadership, which functions through different committees as notified in the college prospectus. The Internal Quality Assurance Cell (IQAC) has been functioning as a quality sustenance measure as it frames the perspective plan of the college and for the effective implementation of the same, the regular meetings of the college advisory committee, Staff Council, designated committees are held where the progress of plan is reviewed. Effective leadership through a participative decision-making process is followed by the Principal delegating the powers to the administrative team comprising coordinator/conveners of different functionary committees. Ensuring the effective planning and implementation of the institutional policies, IQAC helps all the committees to achieve the goal. Annual review and assessment of progress is done by the IQAC through the Annual Quality Assurance Report (AQAR). The preparation of Annual Quality Assurance Report also provides an opportunity to evaluate and improve our functioning every year. Regular performance appraisal of all college activities is done by the IQAC cell.

Finance and Accounts Department works under the supervision of an Office Superintendent, who is directed and controlled by the Principal. Funds of the college under different heads are managed by the Principal in consultation with the Advisory Committee and the college Bursar. The internal and external audits are done regularly to ensure transparency in the financial management of the institution. The official accounts, admission process, service books, etc. are managed through e-portals? PFMS, PMIS, e-salary, online admission portal, etc.

Empowering the faculty, the Staff Council and State Teacher Association strongly advocate for the cause of teaching fraternity. Professional competence of the staff is updated regularly through their participation in orientation/refresher and other in-service training programmes. Mechanism for regular performance appraisal of staff through Annual Confidential Report (ACR) has been evolved to ensure academic excellence.

Institutional Values and Best Practices

The institution strives to provide a student-centric learning environment to the students in the best manner. Besides academics, the sincere efforts are made to accentuate their overall development through various co-curricular activities. The institution takes the responsibility and moral duty to transform the lives of the students by generating awareness about cross-cutting issues of ethics, health, environment, social and gender equity,

legal rights and other issues of social and contemporary relevance among them by building an effective institution-community interface. The college invigorates environmental consciousness among the students through initiatives for energy and water conservation and green campus initiatives. It inculcates values? tolerance and harmony towards cultural, regional, linguistic, communal, socioeconomic aspects and sensitisation of students and employees to the constitutional obligations: values, rights, duties and responsibilities of citizens, etc.

The institution follows the slogan- Go Green, Keep Clean and the main thrust is laid upon the environment-friendly practices combined with education to promote sustainable and eco-friendly practices. Such activities have a shaping influence on the personality of the students. It is believed that the sense of selfless service provides motivation for students to do something worthwhile for the society. It boosts their morale and motivates them to have a better purpose in life.

The distinctive feature of the institution is that it provides better facilities for the girl students to have an access to higher education which remains a distant dream for some girls belonging to the remote areas of the region.

Geographically, the institution is located, in a remote hilly terrain, at the distance of 120 kms from district headquater and 110 kms from the state capital. Keeping in view the locational disadvantages and challenges, efforts are being made by Government College Karsog to further strengthen the infrastructural facilities, to build student-centric environment so that they may become instrumental in bringing about a positive and productive change in the lives the people of the region.

Skill development:	The CBCS system adopted by the college offers a variety of skill-enhancement courses under various undergraduate courses, including soft skills, business communications, samachar sankalan, karyalyee Hindi, rangalekh avam rangmanch, sericulture, legislative support, apiculture, mushroom cultivation, statistical methods, etc. The college also offers options to take courses that would improve one's skills, such as environmental studies, writing, Hindi Bhasha, and Sampreshan, among others. The Language Lab established by the college proved to be successful to develop speaking skills and provide students with knowledge of phonetics. An online admissions/examination portal has also been set up to make the admissions/examination process easier and help students familiarize themselves with IT skills.

Besides, a significant part of the curriculum is accessible in Hindi and other regional languages in the classroom. The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The institution as an affiliated college follows all the rules and directives of Himachal Pradesh University (HPU), Shimla and Sardar Patel University (SPU), Mandi. It strictly adheres to the curriculum developed by the Universities.

At the beginning of the session, the academic calendar is prepared and published in the prospectus. The faculty ensures well-planned curriculum delivery as per the guidelines laid out in the academic calendar. The 'Induction Programme' for new entrants is conducted to familiarise the students with the facilities available in the campus and acquaint the students about the curriculum. For effective implementation of curriculum, teachers are using various teaching methods like chalk and talk, integrated ICT-based methods of the flipped classroom and blended learning. Learning by doing is the best method to understand scientific concepts and students are encouraged to apply the same in their life. The institution has well-established labs of different subjects in which students understand the practicality of these concepts.

The teachers also assess the student's growth and progress through assignments, class tests, group discussions, quizzes, presentations through seminars, etc. To access the progress of students, the Mid-Term Tests are conducted after the completion of 70% of the syllabi. The answer-sheets are checked and shown to the students for clarification and then teachers discuss the question papers in detail with them. For, post-graduate classes, seminars are conducted where invited speakers guide the students about the subtleties of the subjects. Based on the student's performance, 30 marks are credited to their final awards viz. Attendance (5), Class Tests (5), Mid-Term Test (10), and Assignment/Seminar/Presentation (10). The CCA is displayed on the notice board for objections. Further, the CCA is uploaded on the University portal by the respective teachers. The detailed description of CCA has also been included in the college prospectus and uploaded on the college website for the conveience of the students.

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The institution is constantly working towards enhancing the overall learning experience of the students. The introduction of Choice Based Credit System (CBCS) is a major step in making the curriculum student-centric. However, the students are given freedom to choose subject combinations of their choice subject to the availability of faculty and infrastructure. The college offers a number of support services to its teachers for making teaching-learning student centric. The use of interactive learning is promoted through classroom discussions, use of ICT and other interactive resources like video lectures, power-point presentations and other such methods. Two years of COVID-19 pandemic challenged the education system and the college shifted from offline classes to online classes. For the effective teaching-learning during the period, the college signed MoU with "Great Learning" for conducting the classes. The platform provided students an easy access to e-classes and their recording and teachers also rose to the occasion and used the online teaching method. With Great Learning, the teachers got the student daily feedback, conducted quizzes, discussed on the topics, etc.

The college emphasises on developing creative and critical thinking among its students. A host of activities are taken up towards this end. Students are exposed to ICT teaching-learning resources through the use of PPTs and online educational resources, Language-cum-Career Lab, various FOSS and Tally software, etc. For practical exposure, regular practical classes are taken in the subject concerned. They are encouraged to participate in various extra-curricular activities and youth festivals for promoting inclusive and collaborative learning, team spirit and commitment to the task in hand in view of the rounded growth of their personality. Remedial classes for slow learners and extra inputs are provided to the fast learners.

A comprehensive assessment of the academic growth and development of students is made on a variety of parameters ranging from classroom performance, assignments, tutorials/practicals and seminars for objective and continuous assessment of their performance. Seminars, assignments and related activities encourage independent as well as collaborative learning among students. Collaborative learning is also promoted among students through their participation in NSS, NCC, Rovers and Rangers, Red Ribbon Club, Eco-club, Sports and cultural activities. The college magazine, *Kamaksha* is published annually which provides a good platform for the students to develop their analytic, comprehension and writing skills. Activities like field visits, various environmental drives in the locality, expert lectures on health and hygiene, visits to blood banks etc. play an important role in the experiential learning of the students.

The effective, robust and time-bound system makes every effort to resolve the issues raised by the students. Attainment of programme outcomes and course outcomes are the mirror image of the graduate and post-graduate attributes being attained by the learners. Acquiring the properties as enunciated in the graduate and post-graduate attributes is a constant evolving process, which requires continuous monitoring and corrective remedial measures. We have adopted a learner centric approach and evaluate student's knowledge acquisition, skill development and employment readiness. The IQAC of the college has designed a specific and systematic methodology for the assessment of outcome attainment levels.

Programme specific attainment is measured as an average of course outcome attainment of all the courses in that specific programme which includes all the students who are enrolled in a particular course irrespective of their main core subject. The programme outcome attainment is measured in respect of all the students on the basis of their final CGPA at the time of passing the programme.

The attainment levels of the course outcomes are measured by the concerned course handling faculty members through various assessment methods. Being an affiliated college of Himachal Pradesh University and Sardar Patel University, student's academic performances is evaluated through 70% of marks obtained in annual examination and 30% marks obtained at college level comprehensive continuous internal evaluation. The assessment of the attainment of course outcomes is supplemented by the comprehensive continuous internal evaluation system which includes assignments given to the students, ICT enabled seminars and presentations, individual/group projects, class tests, followed by viva- voce on the completion of project. Apart from this, the course outcomes are also evaluated through midterm, theory and practical examinations.

The focus of the programme outcomes and course outcomes have been maintained even when the classes have transited through online mode during Pandemic. Attainment of course outcomes of the course is determined from the performances of students through assessment tools. The level of attainment of each course outcome is compared with the pre-defined target, if unachieved, then the course teachers take

necessary steps for the improvement of the target.

Response:

The infrastructure and physical facilities of the college ensure the smooth functioning of all the courses offered across the three streams? Humanities, Science, Commerce, post-graduate courses and add-on courses. College provides an academically and technically sound environment to the teachers and students for overall growth and development. Major maintenance and construction of building and support facilities are implemented through state government policies viz. minor maintenance work and students convenience are provided by the funds generated by the college through students fees and funds.

College building has eighteen classrooms out of which four are smart classrooms, Conference-cum-Seminar Hall and one Examination / Multipurpose Hall. Eleven laboratories in the college bear testimony to the importance of experimental learning. College has two labs each in the Department of Chemistry, Physics, IT labs, one in Botany, Zoology, Geography, Computer Applications and a Language-cum-Career lab. The college has a common Staff Room with basic facilities and faculty cabins with computer facility. The college provides Common Room for Girl students and well-maintained girls and boys lavatories within campus have been made available. Separate fresh drinking water facility has been made available for the students within the campus. In order to equip the students with latest knowledge, the college has a Library with 14,475 books and there is INFLIBNET Facility for the students as well. NCC, NSS and R&R have been provided with separate rooms to carry out their work. The college makes residential facility available for the girl students through its well-maintained hostel with a residing capacity of fifty-three girls. College has canteen facility available for staff and students. There is a provision of Public Address System for important announcements. Proper parking space has been demarcated for parking the vehicle. Besides, there is an IGNOU study centre equipped with adequate amenities. College also hosts a Botanical-cum-Herbal Garden with many medicinal important plants for study purpose. CCTV cameras have been installed in the college and Girls' Hostel for monitoring all the activities of institution for ensuring the safety of the students. Additional Academic and Administrative Blocks are under construction adjoining the college building. Although the college have limited land available for new constructions and other facilities but an auditorium in the central courtyard is being made. The roofing, flooring work has been completed and the process of putting chairs is under process.

The college has adequate indoor and outdoor sports facilities like Volleyball, Badminton court, Chess, Carom, Table-Tennis, Kabaddi, Boxing and Kho-Kho, etc. College has a gymnasium with multiple stations like dumbbells, treadmills, chest press, leg extension, abdominal bench, etc.

Response:

The spacious college library having a sitting capacity of 165 seats is an integral part of teaching-learning process. It has a collection of more than 14,475 reference and textbooks of different subjects. All the books are stacked and systematically arranged. The college library is partially automated and uses SOUL 2.0 (ILMS) software for easy management of its resources. Besides, it offers online access to E- journals, e-books through INFLIBNET and NDLI. It has Wi-Fi enabled eleven computers in the e-corner. The library provides the facility for issuing and returning the books and maintains proper record. The faculty and the students visit the library on daily basis to have an access to newspapers, magazines and journal.

The library committee appointed by the Principal ensures the smooth functioning of library. Its major function includes purchase of textbooks and reference books, proper upkeep and stacking of books and subscription of magazines, journals and newspapers. The library has the book bank facility that caters to the needs of the needy students.

The comprehensive IT policy of college is to support and facilitate the teaching-learning process. To enhance the academic activities, the IT facilities are updated at regular intervals as per the requirement. In the last five years, the institution has shifted from wired broadband connection to Bharat Fibre high speed connections thereby increasing the college's bandwidth from 8 mbps to 250 mbps. This updation was done on September 24, 2021. An additional bandwidth of 50 mbps will be shortly installed in the campus. A well-equipped lab with 21 computers and other necessary infrastructure is being set up for B Sc students of Computer Applications for which an amount of rupees 14 Lakh has been sanctioned and utilised. New reprography facility has been set up in the campus and old UPS batteries (36 Nos) have been replaced to provide proper backup in the labs. Damaged and out-of-order web cameras have been replaced on May 17, 2023. An interactive panel for video conferencing and teaching purpose was installed in the Conference Hall. The bidding for the three more interactive panels and 10 computers for the GIS Lab of Department of Geography have been placed on the GeM portal and will be installed shortly. In post-COVID scenario, college shifted its admission process to online mode and signed MoU with platform 'Great Learning' for online teaching and ATOM payment gateway for payment of fees and funds through online mode. Updation of information is done on regular basis on the college website.

Perspective Plan

Keeping in view the needs of the institution and feedback from students and stakeholders, the IQAC chalks out the perspective plan of the institution in the beginning of the session.

Policies

Being a Government institution, the policies and rules are framed by the Department of Higher Education of the Himachal Pradesh Government as per guidelines of UGC, affiliating universities (HPU & SPU). These rules and regulations are implemented within the institution in letter and spirit by the head of institution.

Administrative Set-up

The Education Secretary is the administrative head of the institution shouldering the responsibilities of providing staff, infrastructure, financial grants, etc. to the college through the Director of Higher Education. The administrative affairs of the college are managed by the Principal with the assistance of

different committees consisting of teaching and non-teaching staff. In the absence of the Principal, the senior-most faculty of the college manages the affairs of the college. All the financial proposals and expenditures are presented to the Principal by the respective committees through the recommendations the Bursar. All the expenditures are done in accordance with the guidelines of Himachal Pradesh Financial Rules and powers delegated to the principal by the higher authorities.

To regulate and monitor the work different committees are constituted which are published in the prospectus. The decentralised mechanism enriches the effective and efficient functioning of the institution in all its spheres of planning, decision-making, and implementation.

Appointments

The appointments of the faculty are made by the Government of Himachal Pradesh on the recommendations of HPPSC Shimla after the proper selection process. The administrative staff is appointed through HPSSC, Hamirpur. The employees are transferred as per Himachal government policy. To meet the paucity of faculty, the college engages the faculty with the assistance of the Parent Teacher Association (PTA) on a full-time basis. Such vacancies are advertised in newspapers and a proper selection process is followed.

Service Rules and Procedures

All the regular employees are governed by the service rules adopted by HP government which include: FR-SR, CCS (Conduct) Rules 1964, CCS Leave Rule 1972, CCS-CCA Rules 1965, CCS Pension Rule 1972, etc.

Response:

Being a government institution, the salaries and medical reimbursement, etc. are directly credited to individual account by the Government treasury. If the institution requires additional budget for any of its need, the demand is forwarded to the Department of Higher Education and funds are sought. The nominal fees and funds are taken from the students as per government notifications and are utilised for institutional developments as per guidelines issued by the university and government on regular basis. The institution also actively seeks funds from different funding agencies like UGC, RUSA and State Government schemes. The IQAC chalks out the plan of action for every academic year and different committees are formed to execute the same. The performance of various plans is reviewed through the Action Taken Report (ATR).

Institution has an Internal Audit System in which all the bills and vouchers are submitted by the respective committee conveners to office after verification from the bursar. The bursar before finalising the bills/vouchers, checks all the codal formalities including sanction from competent authority, norms mentioned in HPFR, university ordinance, etc. and recommends it for approval. The bill is then finally submitted to the principal for payment. Since Government College Karsog is a government institution, hence, all the expenditure is audited by the government bodies. All the Government funds including salary and arrears, pensions, medical reimbursement, TA/DA bills are audited by Accountant General (AG) Office, Himachal Pradesh. Fees and funds collected from the students and its expenditure is audited by the local audit Department of Himachal Pradesh. The grants like RUSA, UGC, NSS and NCC are audited by the Chartered Accountant.

Response:

Gender Equity and Sensitisation in Curricular and Co-curricular Activities

All the rules and guidelines of the Government to promote gender equity are strictly followed by the institution. It ensures an equal access to all resources of the college like Library, ICT Lab, Language-cum-Career Lab and separate lavatory facilities for girls and boys. There are units of Rovers and Rangers, NCC, and NSS with 50% seats in each for Boy/Girl students. All the units are headed by male/female equally and there is a mechanism to address different gender equity issues, if any. The curriculum of subjects like English, Hindi, Political Science and Sociology include the courses and topics on Gender Equity, Sensitisation and Women Empowerment.

The institution has Sensitisation, Prevention and Redressal of Sexual Harassment (SPARSH) Cell that works in the direction of promotion of gender equity. All the units of college namely SPARSH Cell, NSS, R&R, NCC and other clubs and societies organise various activities on gender sensitisation. Competitions like debate, declamation, slogan writing, poster making and rangoli are organised on the occasion of programmes like International Women's Day. Many dignitaries and officers are invited to deliver lectures on health and hygiene, gender equality, women's rights and women empowerment. Programmes like "KabTak Nirbhaya,""Beti Bachao Beti Padhao" are highlighted.

NSS conducts Seven –Days Special Activity Camp for boy/girls and an equal participation is promoted in cultural activities, inter-college competitions and Youth Festivals. The Dramatic Club of the institution conducts a One-Month Theatre Workshop. About 40 girl and boy students show active participation in the workshop and they get a chance to represent the college in Himachal Pradesh University Youth Festival, Group-IV (Theatre) every year. Moreover, the girl and boy students get an opportunity to represent the college in Youth Festivals and Inter-College Sports Championships as well. The college magazine **Kamaksha** provides ample opportunity for the budding writers of the college, both girl and boy students. Various Scholarship schemes sponsored by Centre and State Government provide equal opportunities for the boys and girls. There is special quota for **Single Girl Child**, and scholarships as per Government norms. **Kalpana Chawla** scholarship is especially provided to the girls.

Facilities for Women on Campus

The institution provides specific facilities for girl students. In terms of safety and security, the institution has SPARSH Cell, Anti-Ragging Committee and Student Grievance Redressal Cell and the CCTV cameras have been installed to keep watch on the activities of the students. SPARSH Cell counsels the

girl students at regular intervals.

Facilities like Girls' Common Room and lavatories equipped with vending machine for girl students in the campus have been made available. Response:

Best Practice I - Eco-friendly Campus: Go Green, Keep Clean

Objectives of the Practice:

- To inculcate the awareness about the environment
- To develop the respect and love for Nature
- To make the campus eco-friendly, green and clean
- To make students the ambassadors of environment so that they can bring a change in the society they live in

The Context:

As goes the saying—"Nature never did betray the heart that loveth her," it is of paramount significance that we need to love and respect nature. Nestled in the lap of Karsog valley, the institution looks glorious. But the trees are quite less in number in the surroundings and so much construction is on rampage. Being hilly terrain, the conservation of nature has become quite important in modern life. The college focuses on encouraging students to respect nature and to keep the campus and their surroundings clean and green. The idea is to inculcate in them the adoration for nature which would be carried forward into their future

lives so that they become catalytic agents in bringing a change in their immediate society.

The Practice:

The institution follows the slogan- *Go Green, Keep Clean* and the main thrust is laid upon the environment-friendly practices combined with education to promote sustainable and eco-friendly practices. The college Botanical Garden has diverse medicinal plants like *Aegle marmelos* (bel), *Tinospora cordifolia* (gaduchi), *Withania somnifera* (Ashwagandha), *Rauwolfiaserpentina* (sarpagandha), *Valerianajatamansi* (jatamansi), etc. The college campus is tobaccofree zone and also maintains precautions in making disposal of laboratory wastes. No chemical fertilizers, pesticides, weedicides are used in nourishment and maintenance of plants in campus instead bio-fertilizers are preferred. Triveni—NCC, NSS and R & R carries out one day camps, plantation drives, cleanliness drives to build the eco-friendly campus and extends its help to the community through extension activities, thus, sensitizing the people about the awareness about the environment.

Since 2011, the college has been carrying out the plantation drives every year in the adopted *Mahadev Ki Banauni Forest* in Mumail of Karsog block.

Evidence of Success:

- The Department of Forest has acknowledged and appreciated the contribution of the institution for its activism in various environmental activities. The department has especially acknowledged the remarkable service of the institution in the tremendous increase of green cover of **Mahadev-Ki-Banauni Forest** in Mamail of Karsog block.
- The NSS, NCC and R&R units of the institution were given a *Letter of appreciation* by Sub-Divisional Legal Services Committee, Karsog, Mandi, for Plantation Drive-cum-Awareness Camp.
- The Nagar Panchayat, Karsog and Mamail panchayat have acknowledged the selfless work done by Rover and Ranger unit of the college in cleaning the water sources at Nyara, Kanhi Mandlah.

Best Practice II - Grooming of Personality through Community Interface

Objectives of the Practice:

The Context:

It boosts their morale and motivates them to have a better purpose in life.

The Practice:

Triveni organises the awareness—cum-plantation drives every year. It renders its help in Sanarali Temple during Navratri, assisting the local community and helps in keeping the fair neat and clean and motivate people to do so during the Nalwar Mela also. Apart from the participation in social services, the institution is always ready to provide financial help to the needy and it continues to do so whenever required. NSS volunteers donated Rs. 11,000 to the CM Relief Fund during COVID-19 Pandemic. During the pandemic, the students took initiative to inform the people about COVID-19 SOPs/protocol to be followed for safety measures, prepared and distributed masks, started online campaigns, assisted in hospitals, roads, etc. The NSS started campaigns 'Meri Pathshala' and 'Mission Gyanodaya' in which volunteers taught the children in their home and donated books to the needy. The social service done by students extends outside the state also. The R & R Unit rendered services in Kumbh Mela of Nasik on February 12-21, 2019.

Constant grooming of students by different clubs and societies brings laurels to the institution by bagging positions in Himachal Pradesh University Youth Festivals and Inter-College Championships.

The young actors of the Dramatic Club of the institution regularly perform Mimes, *Nukkad Natak* based on social issues to spread awareness. Stories like *Sadgati*, *Kafan and Idgaah* were enacted by the actors.
